- I agree to my child receiving medication as instructed and any emergency dental, medical or surgical treatment, including anaesthetic or blood transfusion, as considered necessary by the medical authorities present.

Photography and Video Image use

Cricket New forest occasionally uses video in the development of players whilst coaching. Photography and video may be used during festival matches and training for coaching and publicity purposes. These images may be used for publication to promote cricket and may also be used on the Cricket New Forest Web site. CRICKET NEW FOREST will follow the guidance for the use of images of young people, as detailed within the ECB Welfare of Young People Policy. Will take steps to ensure these images are used solely for the purposes they were intended, which is the promotion and celebration of the activities of the individuals, team and CRICKET NEW FOREST DEVELOPMENT. If such photographs, e.g. team of action shots, are submitted to the press individuals will not be identified. In exceptional circumstances, e.g. the selection of an individual for Hampshire or England, where there is a need to identify the player to the press, parental permission will be sought beforehand.

Notes for Parents/ Carers/ Coaches & Managers

Club coaches and team managers (qualified or unqualified) have completed a Criminal Record Bureau check. All individuals who have regular contact with children will also be asked to have a CRB check. This district is fully committed to safeguarding and promoting the well being of all its players. The district believes that it is important that members, coaches, administrators and parents associated with the squad should, at all times, show respect, encouraged to be open at all times and to share any concerns or complaints that they may have about any aspect of the organization with the Junior Section Manager.

Junior Code of Conduct

As a member of the New Forest District Cricket Colts Development you are expected to abide by our Code of Conduct for Cricketers:

1. All members must play cricket within the laws and in the spirit of the game.
2. All members must respect colleagues, opponents and officials. Do not make derogatory comments or gestures about your colleagues or opponents. Never try to intimidate the opposition by threats or excessive triumphalism.
3. Be polite to umpires and respect their decisions. Do not show dissent! Do not throw tantrums or cricket bats. Such behaviour invites sanctions from club officials.
4. Members should keep to agreed timings for practice and matches or inform their coach or team manager at the earliest possible opportunity if they cannot play or are going to be late.
5. All members must wear the appropriate kit – properly! Cricket whites and suitable trainers or cricket shoes should be worn for matches but tracksuits are permitted for practicing.
6. All players under the age of 18 years must wear helmets when batting and when standing up to the stumps when wicket keeping.

Code of Conduct for Parents/Guardians

1. Encourage your child to learn the laws of the game and to play within the spirit
1. of those laws.
2. Discourage unfair play and disputes with officials/coaches.
3. Help your child to recognise good performance, not just results.
4. Never force your child to take part in any sport.
5. Set a good example by recognising fair play and by applauding the good
6. performances of all.
7. Do not enter the changing rooms without prior consent from the manager.
8. Never punish or belittle a child for losing or making mistakes.
9. Publicly accept the judgement of officials without argument or comment.
10. Support your child's involvement and help them to enjoy cricket and to
11. develop within it.
12. 10. Use correct and proper language at all times.
13. 11. Do not forget, children are involved in organised sport for their enjoyment
14. and not yours.
